CALL TO ORDER: President Vandelicht called the regular meeting of the Fayette R-III Board of Education to order at 2:00 p.m.

SPOTLIGHT: Amaya Burchett and Clara Gose, Student Representatives for 2025, reported on all high school activities. Basketball season is in full swing, Courtwarming is being planned, and band is preparing for District Contest.

SPECIAL EDUCATION REPORT: Melissa Duren provided a detailed Census mid-year report on special education services. The December child count has been submitted to DESE with 71 special education students being served, with 5 of those being preschool age.

ADMIN REPORTS: Daly Elementary Principal, Mrs. Hill's report highlighted NWEA has been completed, Boot Camp, and Falcon Party.

Clark Middle School Principal, Mrs. Arnette's report highlighted PBIS party, CMS Basketball concluded, NWEA testing, and the winter concert. She reported an enrollment of 151 students and 94% of CMS students attending.

Fayette High School Principal, Mr. Hannam's, report highlighted finals, winter concert, perfect attendance by staff, leadership teams, and Commercial Trust donated money for students each to have a Flock shirt. Enrollment for the high school is 183, with 92.7% of students attending.

SUPERINTENDENT'S REPORT: Superintendent Doolin's report highlighted snow day decisions, facility improvements, and the SAC Committee.

ACTION ITEMS: Superintendent Doolin recommended approval of an In-House CPI Training Position. Friebe motioned to approve the recommended. Wies seconded. Motion carried 7-0.


